The Japanese version of the Bayh-Dole provision and the obligation to report inventions

Overview of Article 19 of Industrial Technology Enhancement Act (Japanese version of Bayh-Dole provision)


In order to vitalize technology-related R&D activities and promote effective application of research outcomes in business, the government may decide not to take over patent rights etc. from contractors for pertaining to contracted R&D or contracted software development, if contractors promise to adhere to the following four conditions.

- 1. To report inventions and similar research results without delay
- 2. To grant licenses without charge to government for public interest requirements
- 3. To grant licenses to third parties if rights not utilized within a reasonable time
- 4. To obtain approval in advance when transferring patent rights, etc. or when establishing exclusive licenses

The contractor must report created inventions, etc. and the status of such rights to the government or funding agencies without delay.

This is a condition for patent rights to remain with the contractor.

Obtaining approval before transferring IP rights or establishing exclusive licenses

<u>Prior approval must be received from AMED before IP rights are transferred from the contractor to a third party (including the inventor).</u>

* Except for transfers due to mergers or splits, or cases as set forth in Item 3, Article 11 of the Order for Enforcement of the Industrial Technology Enhancement Act.
